

GETTY IMAGES CONTRIBUTOR AGREEMENT FOR PHOTO SHARING CONTENT RATE CARD

This Rate Card, effective as of June 7, 2011 (the "Effective Date") amends and varies the terms of the Getty Images Photo Sharing Agreement between you and Getty Images (US), Inc. (the "Agreement") as set out in the "Royalties" section of the Agreement.

All capitalised terms not otherwise defined in this Rate Card shall have the meanings given to them in the Agreement.

1. **Royalty Free Still Images in subscriptions:**

With effect from June 7, 2011, Accepted Content uploaded and accepted after June 7, 2011 and licensed through a Value-Tier Royalty-Free Collection may also be distributed through Getty Images' subscription-based online distribution platform, www.thinkstock.com, including all foreign language versions ("**Thinkstock**") and other Getty Images-owned or operated subscription platforms. "**Value-Tier Royalty-Free Collection**" means one or more collections that may be created by Getty Images that offers Accepted Content at prices below then-current pricing for the original Flickr (royalty-free) Collection. For the avoidance of doubt, Accepted Content in the original Flickr (royalty-free) collection will not be distributed through a subscription-based online distribution platform.

The Royalties per initial download payable to you in respect of Accepted Content downloaded by Clients from Thinkstock shall be the amounts set out in Appendix 1. The provisions of the Agreement contained in Section 1.4 and in the "Royalties" table within the Commercial Terms shall be varied to the extent necessary to give effect to the foregoing but shall remain unchanged in respect of all other uses of such Accepted Content and for all uses of other Accepted Content.

All other terms and conditions of the Agreement shall remain in full force and effect.
