This Getty Images Contributor Agreement Rate Card v.5.0 (the "Rate Card") is issued in connection with the Getty Images Contributor Agreement v.5.0 (the "Contributor Agreement"). Except as specifically defined in this Rate Card, all capitalized terms are defined in your Contributor Agreement.

The charts below sets out the royalty rates that Getty Images pays to Contributors, based on the type of content and the applicable license model through which Accepted Content is licensed. Getty Images will determine the license model for each transaction and it may license Accepted Content to multiple Customers through one or more license models, at any given time.

Except for Royalties on creative subscription products, which are paid in accordance with the subscription schedule below, all other Royalties are calculated based on **License Fees** applying the following rates:

"License Fees" as defined in the Contributor Agreement are: (a) the amount charged by Getty Images or a Distributor to each of their Clients (or in the case of certain Distributors, the amount charged by Getty Images to those Distributors for royalty free licenses); (b) the amount recovered from a third party infringer in connection with a Claim (as defined in Section 1.6 – Right to Control Claims); or (c) the amount of revenue, including advertising revenue, that is allocated to the Accepted Content pursuant to Section 1.4 (Aggregated Licensing).

## **Subscription Royalties**

For all Accepted Content licensed through a creative subscription, Royalties will be paid based on the initial Customer download of a particular asset, as follows:
